## 2018 VENDOR RULES

---

VENDOR hereby contracts with the Manistee Area Chamber of Commerce for space at Grapes on the River as follows:

1. VENDOR agrees to use and pay for booth space as described. VENDOR agrees to accept space assigned and will not sub-let to anyone else.
2. Neither the Manistee Area Chamber of Commerce, the Grapes on the River Committee, Edward Jones - Jeff Reau nor the City of Manistee will be responsible for any injury which may arise to VENDOR, their employees, agents, guests or customers; or for the loss, theft of or damage to any food, display, merchandise, samples or vehicle from any cause whatsoever while in transit to or from, or while participating in the Grapes on the River. By executing this contract, VENDOR agrees absolutely and irrevocably to waive and release any claim it may have against the Manistee Area Chamber of Commerce, the Grapes on the River Committee, Edward Jones - Jeff Reau nor the City of Manistee, their officers, officials, agents or employees.
3. When ACTS OF GOD or any other causes not within the control of the Manistee Area Chamber of Commerce, the Grapes on the River Committee, Edward Jones - Jeff Reau nor the City of Manistee make it impossible for the VENDOR to occupy the Festival premises, then in such case the Manistee Area Chamber of Commerce, the Grapes on the River Committee, Edward Jones - Jeff Reau nor the City of Manistee, their officers, officials, agents or employees are jointly released from any and all claims for damages which may arise as a consequence thereof.
4. The VENDOR also agrees to the following conditions of this contract:
  - a. Setup shall be completed between **1:30 PM - 3:30 PM August 11**; cleanup must be completed prior to **10:00 PM on August 11**.
  - b. Booth sharing by VENDORS is **not** permitted.
  - c. The VENDOR agrees to utilize volunteers provided by the Manistee Area Chamber of Commerce.
  - d. The management shall be entitled to close a booth at any time for failure of VENDOR to perform, observe and comply with any term set forth in the contract.
  - e. VENDOR shall not be entitled to a refund or any part of any fee should he/she, for any reason, is unable to participate after acceptance.
  - f. If for any reason the management determines that the location of the VENDORS should be changed or dates should be changed, management reserves this right.
  - g. All pertinent laws, ordinances and regulations pertaining to health and public safety shall be strictly observed.
  - h. VENDORS shall have appropriate license, insurance and local health department permit if applicable.
  - i. VENDOR will cooperate by keeping VENDOR area clean.
  - j. Exhibits left over-night are at the VENDORS' own risk.
